# ENTRY RULES

Please read through the entry rules below, before completing the nomination form.

You can either nominate your own company or you can nominate another company/individual that you have worked with that is registered with ESDP.



- ▶ For Business Awards, applicants can enter for one or more categories.
- ▶ Applicant information will be treated as confidential and will primarily be used for the purpose of judging the ESDP Business Awards.
- ▶ Specific information provided on the nomination forms may be used for PR and Media Promotion of ESDP 2023 Business Awards. All nominee-specific copy to be used for media purposes will be cleared with the applicant before publication. Subject to the foregoing and the provisions of the Freedom of Information act and Data Protection act, confidentiality will be maintained.
- ▶ Entries will be judged by a panel of 3 eminent and impartial adjudicators, 3 per award.
- ▶ The decision of the judges is final and no correspondence will be entered into. The winners will be the businesses that, in the opinion of the judges, demonstrate the greatest fulfilment of the award category criteria.
- ▶ Nomination forms must include all required information and be signed by a senior executive of the nominated company or by the nominated individual or whomever can certify that this information is accurate and verifiable.
- ▶ Nominees must be financially viable. A copy of the most current financial statements must be submitted with the nomination form.
- ▶ Once received by ESDP, all nomination forms will be at all times the property of ESDP and none will be returned. Entries which have been obtained or made through fraudulent means are subject to disqualification.
- ▶ Winners will be announced at the ESDP Business Awards Dinner on **Thursday 21st September 2023**, held at the Het Scheepvaartmuseum, the National Maritime Museum in Amsterdam.
- ▶ We encourage all finalists to attend the evening with their team/colleagues to celebrate business success.

## European Supplier Diversity Program of the Year

**This award recognises a corporate member that has demonstrated exceptional commitment and leadership and driven significant growth in supplier diversity in Europe this year.**

The Judges are looking for evidence in one or more of the following areas:

- ▶ Impact of the approach on the business and to customers.
- ▶ Evidence of a sustainable supplier diversity strategy in Europe.
- ▶ Steps/actions taken to measure results or achievement.
- ▶ Tangible and measurable outcomes.
- ▶ Evidence of driving supplier diversity through their tier one supply chain.
- ▶ Demonstration of any unique or best practice approach to the issues.
- ▶ Impact and engagement of senior leadership and team participation.
- ▶ Innovation in the design and in the delivery.
- ▶ An understanding of the needs of, and impact on, ethnic minority businesses.
- ▶ Number of RFP's/RFI's presented to MSDUK /ESDP.
- ▶ Evidence of measurable outcomes and effectiveness of the programme.



## European Supplier Diversity Advocate of the Year

**This award is given and selected by the MSDUK team.**

We are rewarding:

- ▶ An individual's support and commitment to MSDUK/ESDP and its EMB suppliers.
- ▶ An individual's efforts internally to champion supplier diversity and MSDUK/ESDP.
- ▶ An individual's proactive efforts to introduce or amend processes that encourage the introduction of more diverse suppliers within the supply chain.
- ▶ An individual's level of participation in MSDUK/ESDP activities (i.e. regular meeting attendance, regular event attendance, speaking at MSDUK/ESDP Events).
- ▶ An individual's involvement in training or mentoring EMBs.
- ▶ An individual who has acted as an ambassador for MSDUK/ESDP.

- ▶ Innovation in the design and in the delivery.
- ▶ An understanding of the needs of, and impact on, ethnic minority businesses.
- ▶ Evidence of measurable outcomes and effectiveness of the programme.

## Innovation Award

This is given to the winner of the MSDUK 2023 Innovation Challenge.



This award is given to the overall winner of the European Innovation Challenge '23, selected from our category winners. The award's winner has demonstrated that their innovative idea is impressively creating a better world, pioneering innovation at its best, and recognising the outstanding contribution the ethnic minority and immigrant-owned entrepreneur has achieved.

The ESDP European Innovation Challenge is Europe's first competition for ethnic minority or immigrant-owned businesses. The 3 categories for this year's Innovation Challenge are:

**Digital transformation:** awarded to pioneering business solutions that innovatively tackle the challenges in today's world. Awarding the idea that is transforming how people live, work and play.

**Social Impact:** awarded to the business that has created solutions that tackle some of the most pressing societal issues. Recognising an innovation that helps to create thriving communities.

**Healthcare & well-being:** awarded to the business with outstanding solution-led products or services designed with cutting-edge technology, helping improve the health and well-being of our people.



## European Social Impact Entrepreneur of the Year

The European Social Impact Entrepreneur of the Year award recognizes outstanding individuals who have demonstrated exceptional leadership and innovation in creating positive social impact through their business.

Open to ESDP Registered businesses; the judges are looking for evidence in one or more of the following:

- ▶ Nominees should have a proven track record of creating sustainable and scalable business models that generate positive social and environmental outcomes.
- ▶ Demonstrate a commitment to ethical business practices and corporate social responsibility.
- ▶ Demonstrate their innovative solutions to address some of the most pressing social and environmental challenges facing Europe today. These challenges may include poverty, inequality, climate change, environmental degradation, or any other issue that impacts society as a whole.
- ▶ Strong leadership and management with the ability to drive the business forward.
- ▶ Understanding of the market and mechanisms to respond to change.
